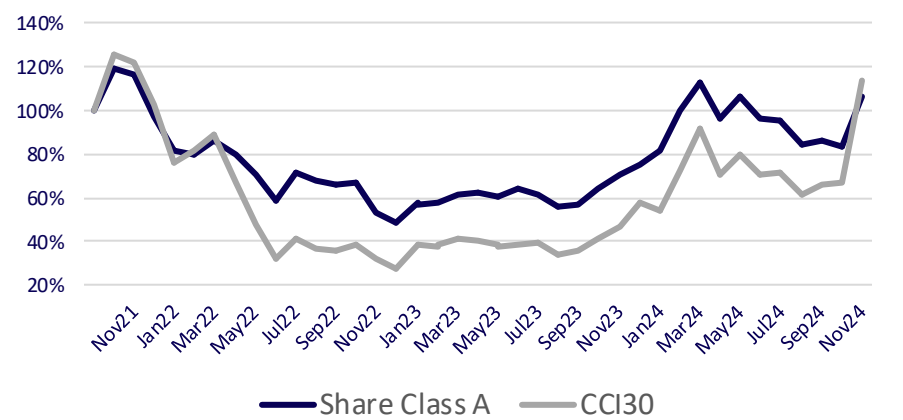


Investment Policy of the Fund

Zenith PrudentBull Fund is a fund of funds focused on quant-based trading funds in the digital assets space, aiming to achieve exceptional risk-adjusted returns. Zenith PrudentBull Fund provides investors access to a diversified portfolio of thoroughly selected funds in the digital assets space. By carefully selecting and balancing fund components, Zenith seeks to outperform the CCI30 Index by capturing upside potential in the dynamic crypto market while prioritizing robust risk management.

The drawdown in November 2022 was the result of the FTX exchange collapse. Diversification across multiple funds, maximum allocations per exchange, thorough risk management, and rapid intervention limited losses.

PrudentBull Diversification

Zenith’s PrudentBull Fund consists of a well-diversified portfolio of around 6 - 12 target funds. The teams are located in four different major regions (Central Europe, North America, South America, and South-East-Asia) and are trading different tokens within a 500+ coin universe on few selected decentralized exchanges. The different strategies draw on a wide range of financial instruments (perpetuals, swaps, options, etc.) and can be assigned to the following main buckets: discretionary trading based on fundamental analysis and/or quantitative signals, trend-following and/or mean reversion, and other sophisticated and market-tailored variants of quant-based trading.

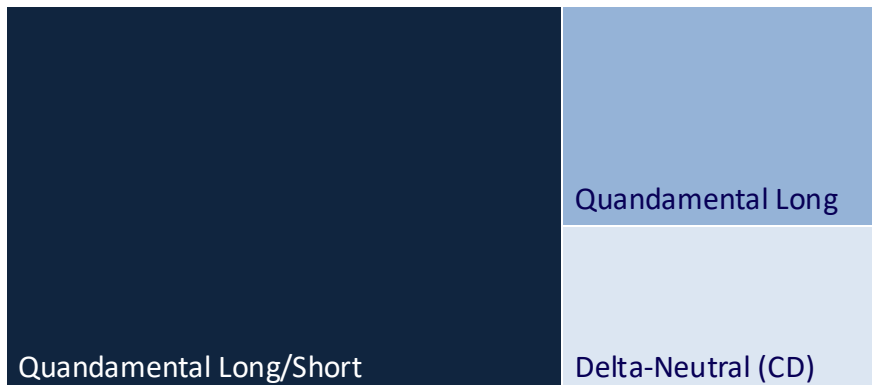

Portfolio Composition

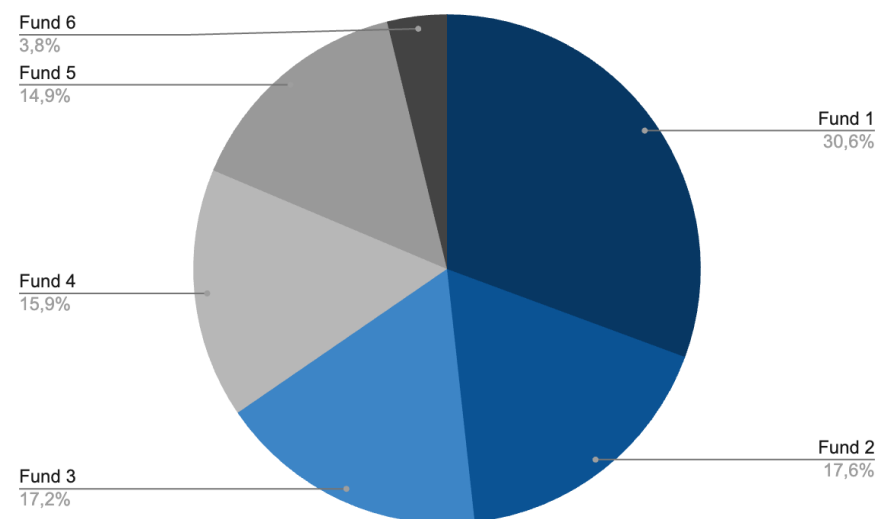
